Abstract
The end of the Cold War was the starting point of renewed visions for a worldwide peace finding their expression in the Agenda for Peace (Boutros-Ghali) and other documents dedicated to the idea of creating a new world order. The 1990s saw a constant increase in international peace missions, predominantly led by the United Nations, whose mandates were more and more extended to implement societal and political transformations in post-conflict societies. However, in many cases these missions did not meet the high expectations and did not acquire a sufficient legitimacy

on the local level. This failure raised critical questions on the conceptual foundations, especially on the liberal blueprints, of peacebuilding practices. The International Symposium "Peacebuilding in Crisis? Experience and New Perspectives" analyzes the international state of the art of peacebuilding processes and discusses innovative approaches opening up new research perspectives on questions of building sustainable peace orders. Finally, it asks for the consequences that have to be drawn for various fields of international peace policies.
